Type of visiting professorship

Guest professor teaching up to 1-2 week (12-20 academic hours) for a module

Selection

The available positions are assigned through a competitive selection procedure, carried out by a GSEM UrFU Selection Committee. Preferential treatment is given to candidates who have never held a visiting position at GSEM UrFU and to candidates who can provide external funding.

GSEM signs individual contracts with the selected visiting professors specifying the form of delivery, the topic of teaching, the agreed number of hours, the remuneration amount, the requirements to teaching and materials.

Payments and conditions

- lecturers with PhD: 72 euro/ac.hour (30% individual tax included, free of other fees and taxes), modules 12-20 ac.hours per week (to be agreed individually) + travel expenses (economy class) + accommodation
- PhD students: 36 euro/ac.hour (30% individual tax included, free of other fees and taxes), modules 12-20 ac.hours per week (to be agreed individually) + travel expenses (economy class) + accommodation

Note: *in case of continuous restrictions for international travel and offline teaching due to COVID-19 pandemic and its consequences, courses delivery in online mode can be discussed. The payment conditions of online teaching are the following:*

- *lecturers with PhD: 55 euro/ac.hour (tax free), modules 12-20 ac.hours per week (to be agreed individually)*
- *PhD students: 30 euro/ac.hour (tax free), modules 12-20 ac.hours per week (to be agreed individually)*

Visiting Periods: 2021-2022 academic year

- **Fall:** September 2021– December 2021
- **Spring:** February 2022 – May 2022
